A not-for-profit organization governed by two trusts: the Hyderabad Eye Institute and the Hyderabad Eye Research Foundation, LVPEI is working towards strengthening Universal Eye Health coverage for all.

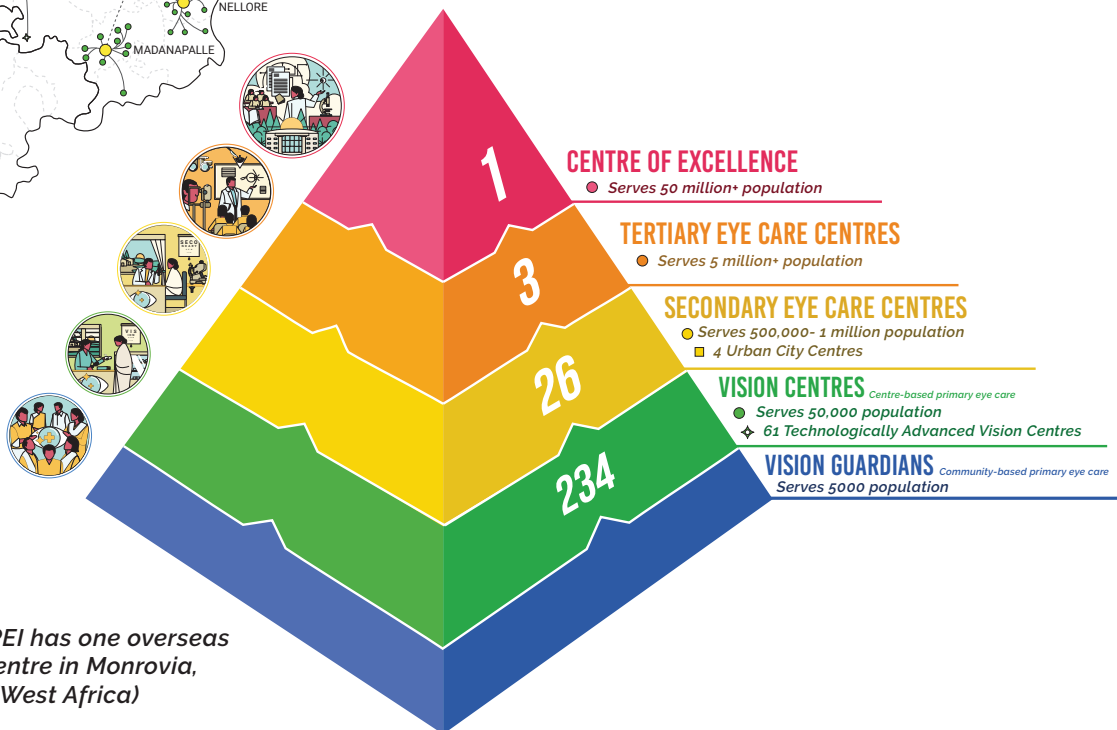
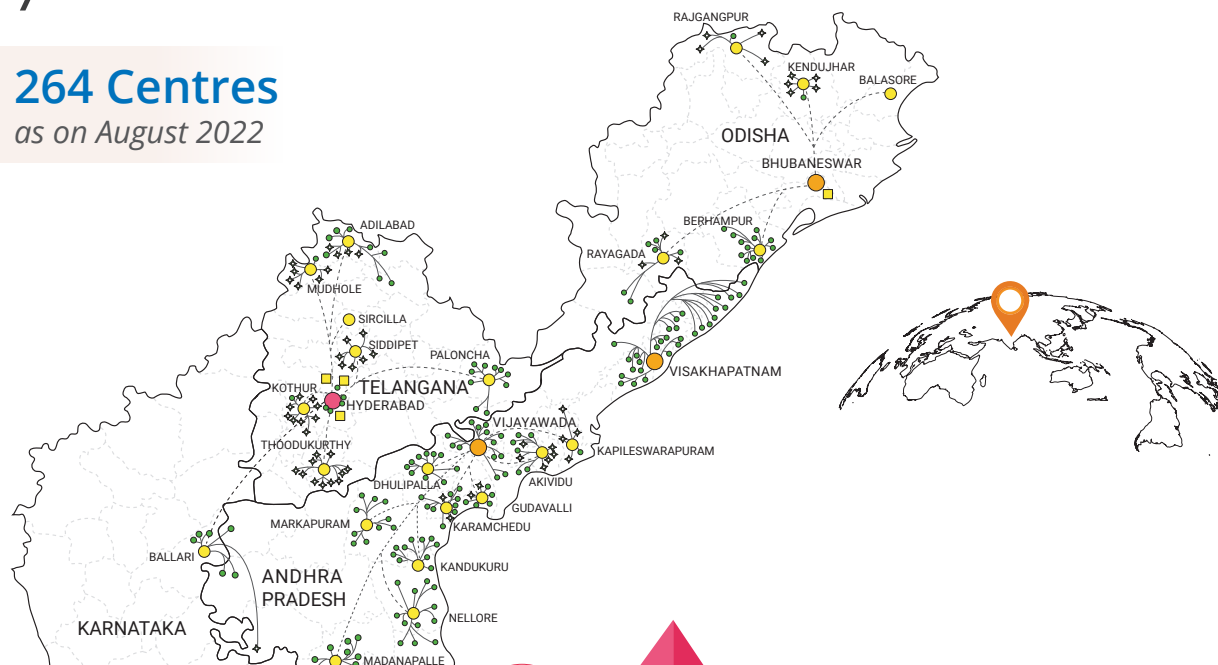
**Vision:** To create excellent and equitable eye care systems that reach all those in need

# Highlights

- LVPEI received the prestigious 'The Greenberg Prize – End Blindness 2020' for its contributions to eliminating blindness
- Stanford University Study named six scientists from LVPEI among the top 2% of world scientists; additionally, 12 LVPEI faculty members were featured among the top eye researchers in India for the year 2021
- LVPEI campuses in Hyderabad, Bhubaneswar, Visakhapatnam and Vijayawada continue to be ranked amongst the Best Eye Hospitals in India by The Week and the Times of India Health Surveys
- Among the very few institutes in the country and also globally to have dedicated facilities for low vision and rehabilitation, children's eye care, elderly eye care, and myopia
- Recognized as one of the world leaders in Eye Banking and corneal transplantations and working towards setting-up Eye Banks in the other states of India
- Recognized as a Centre of Excellence in Ocular Research for the frontline research in unravelling the biological basis of eye diseases and vision-threatening conditions
- Recognized as a national resource centre for training - LVPEI runs several training programs for eye care professionals across cadres from advanced subspecialty training to basic eye care
- The rural outreach, technology and innovation work at the institute is focusing on ensuring 'Universal Eye Health' by bringing down the cost of healthcare and making high-quality eye care accessible to the community regardless of geographic and monetary challenges
